The CDC Is Grossly Underreporting Key Adverse Events

“Every drug or vaccine is toxic at some level, in some percent of people. There’s pretty clear evidence that the spike protein expressed from vaccines is causing toxicity in a small subset of patients. The question is how big is that subset and how bad and broad are those toxicities? And the honest truth is we don’t know. And furthermore, there is a lot of signs that that information is being withheld from us.

“I have colleagues in the government who were fully aware months before . . . cardio toxicity was disclosed that cardio toxicity was an issue.

“What I am hearing now from multiple sources is that individuals are purchasing access, for instance, to the Medicare database — high-net-worth individuals are paying for bio statisticians to independently evaluate those and in some cases bio statisticians and data experts are doing this voluntarily because they are so concerned about what’s going on.

“What they are finding is that the CDC is grossly underreporting these key adverse events in data that the US government produces that is readily available to the CDC. My senior colleagues at the FDA have known that this was the case for months and are very frustrated. This goes back to an interview that I did with Tucker [Carlson] and another bomb I dropped is that these databases are horrible! But despite all their limitations, people with skill are able to data mine those and identify things like the cardio toxicity that at the time the CDC denied existed.


“We have multiple examples where the CDC appears to be editing data in the support of the noble lie . . . the core thesis is — and as I said, it is in the Federal Registry — any information that would cause vaccine hesitancy must be suppressed. That’s what’s going on. Let’s be clear about that. They believe it is OK to do so because it is in the best interest of the public. This is classic noble lie logic. It is also happening in Israel.

“This is a different time. People right or wrong, believe that they deserve to have access to all of these data, make their own choices, exercise their own free will, not be forced into decisions by the government about risks that they don’t fully understand. And the government believes that it is still OK to treat us in this paternalistic manner like they did back in the 50s . . . That’s no longer OK in the modern age.

“What’s different now is that they have these enormously powerful mechanisms for controlling information that they never had before. And that’s the intersection of new media, old media, and big tech. That’s what is going on here. They have never had that level of power before.”

ONE: A bombshell. Alex Berenson, former New York Times reporter, August 6:

“The 300,000 figure comes from an internal update provided to employees by IQVIA, a little-known but enormous company that helps drugmakers manage clinical trials. Headquartered in North Carolina, IQVIA has 74,000 employees worldwide and had \$11 billion in sales last year.”

“Earlier this week, Richard Staub, the president of IQVIA’s Research & Development Solutions division, sent a ‘Q2 2021 update’ which was labeled ‘Confidential – For internal distribution only’.”

“A person with access to the presentation provided screenshots of the relevant slide, which clearly explains the 300,000 side effect reports were received over ‘a three-month span’ – not since the introduction of the vaccine in December...”

TWO: Independent researcher Virginia Stoner has issued a stunning new report on the VAERS numbers, and the effort by mainstream scientists to minimize the destructive effects of the COVID vaccines. Here are key quotes from her report:

“More deaths have been reported to VAERS from the covid shots than from all other vaccines combined for the last 30 years.”

“There’s a code of silence shielding the massive increase in deaths (and other serious injuries) reported to VAERS from the covid shots. Not only do CDC web pages and press releases omit that inconvenient fact – vaccine research studies omit it as well.”

“There are reasons to think death may be one of the most underreported vaccine injuries of all – mainly because the victim is dead, and can’t file a VAERS report. Nor can they prod their doctor into filing a VAERS report. Unless they’re fortunate enough to have a relative or doctor who knows they got the vaccine, knows about VAERS, understands the potential for vaccine injury, and is willing to go through the onerous process of filing a VAERS report, it won’t happen.”

THREE: Open letter from Doctors for COVID Ethics accusing governments and media of lying to the people:

“Vaccinated People Are At Risk; Should Be Put In Quarantine...”

Professor Christian Perronne, MD, PhD:

Vaccinated people are at risk of the new variants. In transmission, it’s been proven now in several countries that vaccinated people should be put in quarantine and isolated from society. Unvaccinated people are not dangerous; vaccinated people are dangerous to others. That’s been proven in Israel now, where I’m in contact with many physicians. They’re having big problems in Israel now: severe cases in hospitals are among vaccinated people. And in the UK also, you had a larger vaccination programme and there are problems [there] also.

But also, the “variants” are not very dangerous. All the “variants” since last year are less and less virulent. That’s always the story in infectious diseases. In my hospital, in March-April 2020, the whole building was full of people with Covid-19: fifty patients. And the so-called “second”, “third”, “fourth waves” were just very small waves, because the hospitals are not full any more. But in the media, they said that all the hospitals were full of patients. That’s not true. Of course, the epidemic was going on, but the “variants” were less and less virulent . . . Yet now, you have governments obliging their citizens to be inoculated with these so-called “vaccines” — and in the countries where they did that, once the epidemic was [already] finished, the epidemic came back, and deaths started again.

I think that the databases [of adverse effects] in some countries are not accurate, because in these cases that I could see, I know that the general practitioners [family doctors] did not want to report the death or the side effect to the authorities, saying, “No, it’s just a coincidence!” So, many, many side effects are not being reported. If there is a stroke, they say, “Oh no, it’s not the vaccine; it’s [just] a stroke; this person was old, so it’s normal to have a stroke.”

Because I speak with my patients (I have some patients who are high-level directors of companies), I know — they tell me — that the physicians in the big companies where many employees were “vaccinated” had problems, but the occupational health doctors didn’t want to report the cases to the French authority. So it’s not being connected with the “vaccine”; it’s [being put down as] “coincidence”.

If we compare the French database with the Dutch database, with the same proportion of patients vaccinated [in both populations], the rate of reporting is much lower in France. That’s not normal! But if we then look at the European level, we see that there are huge numbers of deaths and serious side effects.

We know — it's officially acknowledged by the CDC, the Centers for Disease Control in the United States — that many young people who are "vaccinated" have had heart problems: myocarditis, inflammation of the cardiac muscle, or pericarditis, inflammation of the envelope around the heart. So that's official; it's reported worldwide . . . As we know, children don't develop the disease [Covid-19] at a high rate, and very few children have had severe cases, and the rate of [Covid] death in children is near zero. We now know that the risk of death and of severe problems is much higher if you are vaccinated than not vaccinated [as a child].

And now, we see in some countries that most of the problems, of the cases, are coming from vaccinated people, who are transmitting the disease. And of course, this is not official language, but in France, the government lies: they say, "Although we have seen some cases, it is the fault of the unvaccinated for contaminating the vaccinated."

I'm a Fellow of the Louis Pasteur Institute; I've worked in the field of vaccination for years and years. This is the first time in my life that I've heard from companies, from the manufacturers, from the ministers, from the WHO [such talk]: "It's a very good vaccine — but we have to tell you that if you are vaccinated, you can get the disease anyway! And we're not sure, but it may slow the transmission."

This is not normal. If you are vaccinated with an efficient vaccine, you are protected. You should not have to wear a mask any more; you should have a normal life. But in fact, in many countries, they say, "Oh, you've been vaccinated, but you're not really protected." And now they say to the vaccinated — who are supposed to be protected, who should have confidence! — "Oh, the unvaccinated will contaminate you!"

Now, as regards the "health passport": you know that they published [this proposal] five weeks ago in Israel, and they were close to civil war in Israel. They were fighting inside families. The "vaccine" was mandatory for physicians, for students. And now, they've stopped that [requirement].

In France now, President Macron will speak tomorrow evening, and is expected to say [as he duly did] that vaccination will be mandatory for health care workers, health providers and to participate in some [aspects of] public life. I think this is a great scandal, and I think there will be a civil war if we go this way.



Will COVID-19 vaccines cause a coming tsunami of hospitalization and deaths, along with debilitating chronic disease? One expert on the panel, Dr. Peter McCullough, an internist, cardiologist, epidemiologist and full professor of medicine at Texas A&M College of Medicine in Dallas with a master's degree in public health, said he's focused more on the short-term adverse effects from the shot. These nonfatal injuries fall into four major categories:

1. Neurologic
2. Immunologic
3. Hematologic
4. Cardiac

"What I'm seeing is just the late emergence of various neurologic syndromes. And it probably depends on where the seeding occurs of, uh, of, you know, the uptake of the genetic material in the brain or support cells in the brain, but there's a whole variety of cerebral, cerebellar, even peripheral nervous system abnormalities," McCullough said, adding:²

"I've seen it in my clinic and they seem to be emerging three, four or five, six months later after vaccination ... So I'm getting increasingly alarmed here that this is not just a simple one- or two-day problem. And so there's great concern, particularly in younger kids that over a course of three or six or nine months, they'll end up with heart failure or cardiac death.

... What I see is, potentially from these signals, not mass death, but just a large number of Americans and people around the world with a new chronic disease of some sort of neurodegenerative disease or cardiac disease. The patients that I'm aware of, these problems seem to be quite disabling."

Dr. Ryan Cole, a Mayo Clinic-trained, triple-boarded pathologist, also said that he's seeing potential cancer-causing changes, including decreases in receptors that keep cancer in check, and other adverse events post-vaccine:⁹

"I'm seeing countless adverse reactions ... it's really post-vaccine immunodeficiency syndrome ... I'm seeing a marked increase in herpetic family viruses, human papilloma viruses in the post-vaccinated. I'm seeing a marked uptick in a laboratory setting from what I see year over year of an increase of usually quiescent diseases.

In addition to that — and correlation is not causation — but in the last six months I have seen — you know, I read a fair amount of women's health biopsies — about a 10- to 20-fold increase of uterine cancer compared to what I see on an annual basis. Now we know that the CD8 cells are one of our T-cells to keep our cancers in check.

I am seeing early signals ... what I'm seeing is an early signal in the laboratory setting that post-vaccinated patients are having diseases that we normally don't see at rates that are already early considerably alarming."

As of Thursday morning, there were some 250 COVID-19 patients in serious condition. What are their ages and what is their vaccination status? About 210 of them are individuals over the age of 60. Of the 40 patients in serious condition aged under 60, however, only nine were fully inoculated, one was partially vaccinated and 30 had not received any vaccine. The U.S. agency leading the fight against Covid-19 gave up a crucial surveillance tool tracking the effectiveness of vaccines just as a troublesome new variant of the virus was emerging. While the Centers for Disease Control and Prevention stopped comprehensively tracking what are known as vaccine breakthrough cases in May, the consequences of that choice are only now beginning to show.

At the time, the agency had identified only 10,262 cases across the U.S. where a fully vaccinated person had tested positive for Covid. Most people who got infected after vaccination showed few symptoms, and appeared to be at low risk of infecting others. But in the months since, the number of vaccine breakthrough cases has grown, as has the risk that they present. And while the CDC has stopped tracking such cases, many states have not. Bloomberg gathered data from 35 states and identified 111,748 vaccine breakthrough cases through the end of July, more than 10 times the CDC's end-of-April tally.

"A typical new drug at about five deaths, unexplained deaths, we get a black-box warning, your listeners would see it on TV, saying it may cause death," McCullough said. "And then at about 50 deaths it's pulled off the market." The U.S. has a precedent for this. In 1976 during the Swine Flu pandemic the U.S. attempted to vaccinate 55 million Americans, but at that point the shot caused about 500 cases of paralysis and 25 deaths. "The program was killed, at 25 deaths," McCullough said.

Compare that type of response to the government's reaction to much higher reported death numbers related to the Moderna and Pfizer shots and the contrast is alarming, McCullough said, especially when the shots have not even been granted full FDA approval and are only being allowed on the market under an Emergency Use Authorization. "In the U.S. today [as of late March] we have approximately 77 million people vaccinated for COVID and we have 2,602 deaths reported, so it's unprecedented how many deaths have accrued," he said . . . As a matter of comparison: There are 20 to 30 deaths reported every year to VAERS related to the flu shot. That's with 195 million receiving flu shots. Compare that to the COVID shot, which resulted in 2,602 reported deaths through 77 million vaccinations.

I am writing on behalf of Children's Health Defense to request that you consider the long-overdue need for a comprehensive, high-integrity system to monitor adverse outcomes following vaccination. This request has urgent significance in light of this month's FDA decision to award Emergency Use Authorization (EUA) to the Pfizer COVID-19 vaccine and FDA's imminent issuance of EUA for Moderna's COVID-19 vaccine following abbreviated pre-approval clinical trials. As one of the newly named co-chairs of President-Elect Biden's Transition COVID-19 Advisory Board, a former FDA Commissioner, a professor with triple expertise in pediatrics, epidemiology, and biostatistics — and as someone who has repeatedly called attention to the structural deficiencies of our nation's drug adverse event reporting systems — you are uniquely qualified to articulate the system's existing shortcomings and recommend badly needed improvements.

1. Regulatory officials cannot count on post-marketing surveillance to reveal COVID-19 vaccine injuries because VAERS is broken.
2. The Department of Health and Human Services has ignored numerous opportunities to strengthen VAERS.
3. Although new post-licensure surveillance efforts have emerged over the past decade, they, too, have extensive limitations.
4. Because COVID-19 vaccines are intended for more Americans than any prior vaccine, COVID-19 vaccination promises to bring existing surveillance systems' shortcomings into even sharper relief.

The 67-page motion requests the judge issue a preliminary injunction for the following reasons:

- There is no emergency, which is a prerequisite to issuing EUA and EUA renewals for COVID vaccines.
- There is “no serious or life-threatening disease or condition.”
- Vaccines do not diagnose, treat or prevent SARS-CoV-2 or COVID.
- Known and potential risks of the vaccine outweigh their known and potential benefits.
- There are adequate, approved and available alternatives to vaccines.
- Healthcare professionals and vaccine candidates are not adequately informed.

The authors of the motion attached a declaration by a whistleblower who came forward alleging deaths occurring within 72 hours of receiving a COVID vaccine are significantly under-reported in the Centers for Disease Control and Prevention’s (CDC) Vaccine Adverse Events Reporting System (VAERS) maintained by the U.S. Food and Drug Administration (FDA) . . . In her statement, she said:

“On July 9, 2021, there were 9,048 deaths reported in VAERS. I verified these numbers by collating all of the data from VAERS myself, not relying on a third party to report them. In tandem, I queried data from CMS medical claims with regard to vaccines and patient deaths, and have assessed that the deaths occurring within 3 days of vaccination are higher than those reported in VAERS by a factor of at least 5. This would indicate the true number of vaccine-related deaths was at least 45,000. Put in perspective, the swine flu vaccine was taken off the market which only resulted in 53 deaths.”


